- The vehicle is rented without a driver.

2. Rental Period and Return

- The vehicle must be returned at the agreed time and place.
- Delays will be penalized as specified.

3. Payment and Deposit

- Payment must be made in advance using the methods published on the official website.
- If a security deposit applies, it will be refunded after vehicle inspection.

4. Insurance and Damage Coverage

- The vehicle includes basic third-party insurance.
- The client may choose the 'Full Damage Cost Refundable' option for full coverage.
- Damages from unauthorized use, negligence, or intoxication are not covered.

5. Client Responsibilities

- To care for the vehicle and monitor technical indicators.
- To obey traffic laws and regulations.

6. Penalties

- Delays in return: extra hourly charge.
- Damages, lost keys/documents: fee based on replacement cost.

7. Early Termination

- Early return is non-refundable.
